Natural horsemanship techniques are used and the program validates retraining through participation of the horses in the retreats and carriage driving sessions.

Equine Interaction: Throughout 2024 WRF supported 140 individual veterans and first responders suffering from Post Traumatic Stress Syndrome through 50 day-long Retreats (6 hours), and 45 Mini-Retreats (3 hours). Program events include riding and roping interaction. Total program hours exceeded 2000.

4b (Code:) (Expenses \$ 13,328 including grants of \$ 0) (Revenue \$ 17,482)

Driving: Throughout 2024 WRF supported 12 sessions were held for veterans and first responders, 4-5 per session. 54 veterans and first responders benefited from participation across multiple sessions. Total program hours exceeded 200.

Horse Rescue: WRF did not adopt out any horses but did rescue 2 horses in 2024. WRF currently cares for 3 horses. Training continues on the three horses to rehabilitate, retrain and re-purpose each horse in preparation for adoption to a new home. As part of the re-training, the horses are used in retreats and carriage driving.
